

Celebration of Life Service Package

The Celebration of Life Service includes the supervision and co-ordination of all services requested during the arrangement conference, Celebration Service (Cremated Remains or Photo Present), and final disposition of the deceased. Included are items such as obtaining certificates and signatures, all necessary documentation, which include unlimited proof of death certificates, local transfer of deceased from place of death, preparation as required, and shelter of deceased. Also included is the full use of the funeral home during visitation and the funeral service, and areas such as offices, washrooms, lounge, and parking facilities. Automotive equipment supplied in this package includes a sedan used for funeral administrative purposes, a transfer vehicle.
